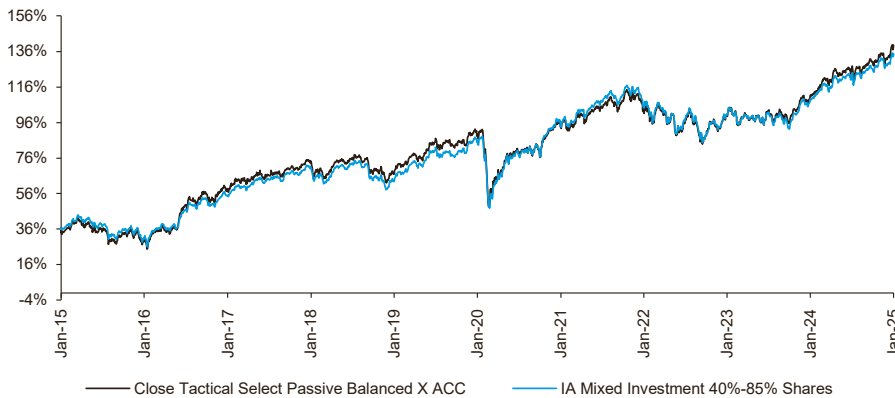
Fund objective

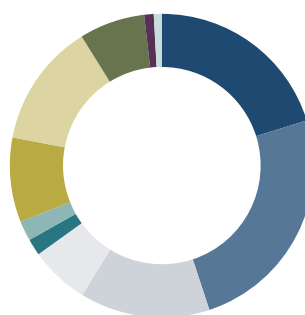
