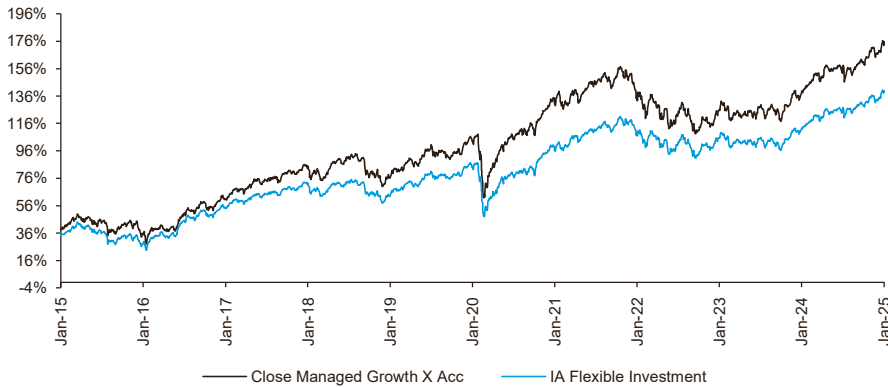
## Fund objective

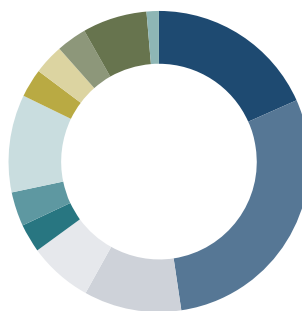
